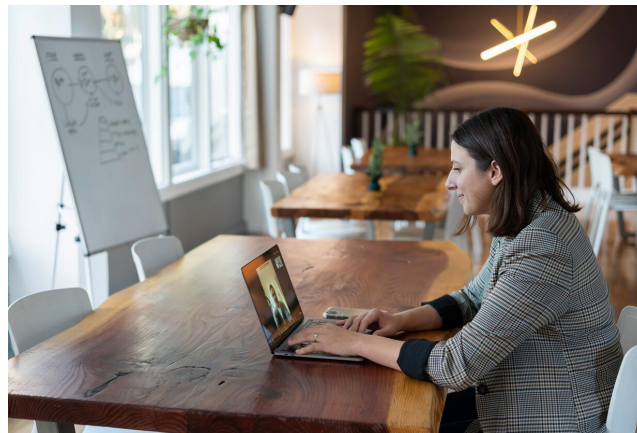
Unfortunately, in 2019, there were 6,205 pedestrians killed and 76,000 injured in traffic crashes. On average, a pedestrian was killed every 85 minutes and injured every 7 minutes in 2019.
