# Are You Driving With "Tunnel Vision" This Winter?

Tunnel vision occurs when a driver scrapes off only a small area of ice or snow on their vehicle windshield to allow just enough space to see through a small hole as they drive. This practice significantly reduces a driver's field of vision and greatly increases their risk of collision. The Kansas Highway Patrol estimates that drivers who do not clear



their entire windshield of ice, snow and fog limit their field of vision to only about 2 to 3 percent of what a driver with a clear windshield can see. In a recent survey conducted by the Center for Safe Driving found that more than 50 percent of drivers admitted to not fully clearing snow or ice from the windows of their vehicles. As a countermeasure, many states have enacted laws

requiring drivers to make reasonable efforts to remove snow or ice from their vehicles, and numerous law enforcement personnel across the country are planning to target drivers who do not clear their windshields this winter. As part of your pre-trip inspection you should make sure that the windshield, side windows and mirrors are clear of any

snow, ice or fog before starting your route or trip. Another dangerous situation that exists is chunks of

snow or ice flying off the top of your vehicle and landing on other vehicles behind you. These chunks can be quite heavy and become dangerous projectiles that can cause crashes, injuries, and deaths. If heavy snow is forecasted it is recommended that you pull your unit away from the dock or terminal building so a drift of snow does not build up from the roof of the building to the top of your trailer or truck. As a professional driver, it is important to recognize this unsafe act in other drivers and be prepared to avoid a collision and stay out of their way.

### **Recognizing a Stroke**

Sometimes symptoms of a stroke are difficult to identify. Unfortunately, the lack of awareness spells disaster. The stroke victim may suffer severe brain damage when people nearby fail to recognize the symptoms of a stroke. Now doctors say a bystander can recognize a stroke by asking three simple questions:

<u>S</u> \*Ask the individual to SMILE. <u>T</u> \*Ask the person to TALK and SPEAK A SIMPLE SENTENCE R \*Ask him or her to RAISE BOTH ARMS

If he or she has trouble with any of these tasks, call an emergency number immediately and describe the symptoms to the dispatcher.




<u>Sign of Stroke</u>: Stick out your tongue as you ask the person to stick out their tongue. If the tongue is crooked or if it goes to one side or the other, that is an indication of a stroke.

## New York Changes Course, Will Now Enforce ELD Mandate



The State of New York reversed course on enforcing federal electronic logging device (ELD) rules and can now enforce the ELD mandate. An emergency rule-making was issued in the NYS Register on January 16, 2019, meaning as of January 17, drivers not in compliance with the ELD mandate could be placed out-of-service. The rule change comes weeks after a New Year's Eve opinion from Judge Richard M. Platkin dismissed a case from the Owner Operator Independent Drivers Association (OOIDA) that argued that the New York DOT was enforcing the ELD regulations even though state statutes did not give it the authority to do so.

In issuing his decision, Judge Platkin said that the state's policy was that "no tickets or Notices of Violation are to be issued citing the federal ELD regulations, and no violations of ELD rules are to be cited on the inspection report." Before enforcement, inspectors could ask to see driver's logs and review logs on an ELD screen to enforce HOS rules, but drivers could present either paper or electronic records.
